## **Preface**

This essay was written many months before the Australian 14 October 2023 Referendum, and at a time when the polls were indicating majority support for the 'Yes' campaign.

**The purpose of this essay was to try to enlighten those who would vote 'Yes',

Every word in this essay, -the writer believes, is the absolute truth  
and, -in the cases of speculation, is as close to the truth as one could reasonably expect.

It was however, words from the mouths of **Albanese, Pearson, Mayo, and Langton**

Adding those pages, -in turn, resulted in the writer changing his opinion

## Truth Time

Of Australia's entire population, **less than three percent** are the people who claim to be '**Aboriginal**'.  
Of that three percent, there is **a minority of people** who have **genuine Aboriginal blood** in their veins,  
and **only they** can legitimately call themselves Aboriginal.

Those other people, -who call themselves Aboriginal, are not so, and they never will be so.

They are of mixed racial blood, and the overwhelming majority of them  
have more white blood running through their veins than black blood.

People of mixed race are the product of two, or more, distinct and genetically dissimilar races.  
**They are not, and they cannot claim to be, exclusively of one race.**

Those persons of mixed race, who mistakenly call themselves Aboriginal, are not Aboriginal,  
they are **hybrid**, -what our American cousins call 'half-breeds'  
and, -until such time as a more suitable word is found,  
**hybrid** is the word that should be used to describe them.

As an example, Noel Pearson, Linda Burney, Thomas Mayo and their mates are hybrids.  
**They are not today, and they never will be, 'Aboriginal'.**

### To illustrate the point

If such creatures as 'Martians' existed,  
and if a 'Martian' was to mate with an 'Earthling',  
the product would be a creature part Martian and part Earthling, -a hybrid.

It could not claim to be exclusively Martian, nor could it claim to be exclusively Earthling  
because it would be neither,  
and **exactly the same** applies in the case of the product of any other combination  
of racially and genetically different parents.

In the case of a part Australian Aboriginal and part something else person,  
the time has come to find a more suitable, friendlier and honest description of hybrid persons.

The time has also come for Pearson. Mayo, and the other eighteen members of The Gang of Twenty,  
-together with their supporters and associates,  
to be arrested, charged, convicted and sentenced for their crime  
**of attempting to racially divide Australians,**  
and the punishment should be severe,  
-keeping in mind that we live on an overpopulated planet,  
and that every little helps.  
-and now, back to Truth Time.

## The Real 'Referendum' Story

**Albanese did not just wake up one morning and think, "Oh, today I'll call a Referendum".**

Within minutes of the result of the May 2022 Election being declared, Albanese was at the microphone announcing that **'He intended to hold a Referendum'**, and he clearly, and indisputably added- **"I intend to implement the Uluru Statement in full"**, even though, -as late as today, he freely admits to having never read the Uluru Statement.

**He hasn't read it. He knows nothing about it, yet he intends to fully implement it.**

From this point on, the writer will refer to them as being **'The Gang of Twenty'**.

**'Noel Pearson'** is the leader of **The Gang of Twenty**.

Noel Pearson is a nasty, bad-mouthed person of mixed racial blood  
and, -without question, he is 'as-big-a-racist and hypocrite' as any that ever existed.

It was **Pearson** who started the campaign, **'To take back ownership of Australia'**

Little wonder that the gang, -and their-complicit-friend Albanese,

of

**'Their real agenda'** is about changing the almost faultless Australian Constitution to enshrine **'Aboriginal Law' over Australian Law**, and to enshrine **'the Aboriginal Claims of Sovereignty'** into the Australian Constitution, -what the troublemakers call- **'Taking back ownership of Australia'**, together with **exorbitant claims for financial reparation and compensation** for **the hurt, distress, and damage** that 'the Invaders' have caused to the Aboriginal people.

There is also something that they call **'Unfinished Business'**

-but no-one, -other than the gang of twenty, knows what 'that' is supposed to mean.

**-this 'Voice to Parliament' is something that is to be feared**

because, once the Australian Constitution is changed to include the hidden details it will be absolutely impossible to change it back to what it is today, and Australia will be burdened with it for the rest of time.

**It is no wonder that Albanese is determined to keep the details secret from the Australian people.**

There are many groupings of people living within Australia's bounds.

Apart from 'itinerants' and 'tourists' **we are all Australian.**

Unfortunately, one group of people does not see themselves as being such,  
-and we are referring to those hybrids who identify themselves as '**Indigenous**', or '**Ethnic**' Aboriginals

'Fifty-Thousand-years' is 'a-mere-blink-of-the-eye' in the eons of time,  
and it is of no consequence whatsoever, and can be discounted.

**'Ethnicity'** comes about by choice.

**Ethnicity is intangible, it has no substance. It lives only in the confused mind.**

Anybody can claim to be 'ethnic-anything'.

It is '**Race**' that is important. It is '**Race**' that matters,  
**and Race is acquired by birth.**

The writer would prefer to use the words 'Pseudo-Aboriginals' in place of the words 'Hybrids'. The meaning however is much the same. 'Pseudo' meaning 'false or fake', -not 'real' Aboriginal.

Australia's 'Pseudo-Aboriginals' need to understand that-

**Only people with One-Hundred-Percent Aboriginal Blood in their veins are Aboriginal.**  
**Only they can legally and morally call themselves 'Aboriginal'.**

**Anyone with less than One-Hundred-Percent Aboriginal blood in their veins is not Aboriginal.**  
**They never can be, and they never will be.**

Those persons are of Mixed Racial Blood, and are Pseudo-Aboriginal,  
 and can be legally classified as 'hybrid'.  
**and, -as such, they can have no claim whatsoever to the Sovereignty of Australia.**

Kangaroo and Possums may have a claim to the Sovereignty of Australia.  
 Full-Blood-Aboriginals do **not** have any such claim, -they are an introduced species,  
 but they do have a case to answer  
 in respect of **the genocide, -the slaughter,** of **the Melanesian First People of Australia.**

**There is nothing to be ashamed of in being a hybrid.**

Such people did not choose to be so, and they cannot change it. It is the way they are.

If the reader is a hybrid, -and if you have got a problem with it, sort it out with your parents,  
-otherwise just try to learn to live with it.

The word hybrid means 'of mixed racial blood'. Nothing more, nothing less.

You are not alone, there are millions of such people, -more than you can point a stick at.

If one of your parents was Aboriginal, or part Aboriginal,

and the other parent was something-else, or part something-else, **then you are not Aboriginal.**

You cannot identify with the people who lived in Australia before the 26 January Colonisation Day,  
so just be grateful that you are an Australian.

If the above applies to you, and if you happen to be one of the trouble-making activists

then not only should you be grateful that you are an Australian,

you should start to behave like one,

-and these words are intended for the likes of **Thomas Mayo, Patrick Dodson,**

**Linda Burney,** and others like them.

The reader might have noticed that the biggest trouble-maker of all, **Noel Pearson**

was excluded from the list. It was intentional, because-

‘It could possibly have been’ that, when the aggressive-Aboriginal people  
**invaded Melanesian-occupied Australia**  
the name ‘Pearson’ was a quite common name.

If it was, then Mr. Pearson could still be a full-blood Aboriginal.  
This ‘could’ have been the case.

The writer doubts that it was, but he cannot prove otherwise.

**The only alternative is that ‘Mr. trouble-making Pearson’ is no different to the others.  
That he too is of mixed racial blood, and that, -as with Burney, Mayo, Dodson and their mates,  
he is just another ordinary trouble-making hybrid with no claim whatsoever to Australia.**

**As hybrids, Pearson and his mob have no claim whatsoever  
to the Sovereignty of Australia,**

**-and ‘they will only get Sovereignty over Australia’  
if the reader votes for them to do so.**

As the writer recalls, 'On the sixth day of January 2023, it was reported on ABC television that the Lawyer, Michael Mansell, -the then chairperson of the Aboriginal Land Council of Tasmania, **first let-slip the truth about 'Aboriginal Law'**. It was a law that we knew nothing about.

**Whether, -at the time, Mansell's lips were loosened by alcohol, is not known by the writer, but let it slip he did.** It happened thus-

**-no doubt, doing the ironing.**

For your information Dowton. **'Yachts are steered'**. **It is** the wind that does **'the driving'**.

**The yacht, still seaworthy, and no worse for wear**, washed up on Cape Barren Island, Tasmania, on January 6, 2023. **-abandoned by persons who had no right to be at sea.**

**Someone at Rushcutters Bay (CYCA) should be held to account for this dilution of quality.**

A message for **Dowton**, for **Adam Goodes**, for **Victoria Logan**, for **the other four**,  
and for any other wanna-be 'Ocean Racers'.

**"Before you next leap onto the radio 'and start screaming to be rescued', take a look around.**

Get below deck and find-out just where the water is pouring-in through the damaged hull,  
and then do whatever you can to slow or stop it.

Get your intrepid passenger over the side with something to cover the damage,  
and start bailing-out.

Only when the water is up to your arm-pits, and engine-oil is coating its surface,  
is the time to start thinking about readying **the life-raft.**

**But better than all of that, do everyone a big favour, and stay away from anything that floats  
because people such as 'You', -who abandon a perfectly seaworthy, undamaged yacht,  
give sailing, and proper sailors a bad name.**

I have got some really nasty words for You lot, but I'll save 'em 'till I see your faces!"

To the responsible person at 'The Cruising Yacht Club of Australia', I say this-  
**"You Sir, -or Madam, deserve to have a giant boathook jammed up your useless arse!"**  
**because you are as guilty as the clowns who you permitted to enter the race.**

I'll tell you reader, they don't make 'em like they used to.



For the record.

As the for'ard hand on a half-ton yacht, -during an IOR event,  
this writer was the first yachtsman in Australia 'to peel spinnakers',  
-perhaps even the first one on this planet to do so.

The yacht was named 'Rebel'. The time 1974-ish. The place, somewhere east of Australia.

-----

It was on 6 January 2023 after Mansell, -the pseudo-Aboriginal Lawyer, had become aware  
that the yacht Huntress had washed ashore on Tasmanian soil, that he excelled himself.

**It was on that day that Mansell let slip the truth about Aboriginal Law,  
-the very secret, recently invented Aboriginal Law,**

when he announced that Aboriginal Law states that-

**"Of everything that lands on Aboriginal soil, or in its waters,  
'One Third of its value' belongs to the Aboriginal people."**

**If the house in which you live is on 'Aboriginal land',** *(-and according to Mansell, 'Aboriginal land stretches from the Pacific Ocean to the Indian Ocean, and from the Great Southern Ocean to the shores of New Guinea and Timor l'este.')*  
**then One Third of the value of that house is due and payable to the Aboriginals.**

If you, or your landlord cannot pay, then One Third of the house becomes Aboriginal property, and if they want to rent their share of the house to other pseudo-aboriginals, or to anyone-else, or to move in with you, to occupy their One-Third of the house, there will be nothing that you can do.

It will include One Third of your furniture, your pots and pans, your crockery, your bed, your TV set, your clothes and shoes, the children's clothes and toys, the lawn-mower, your car or motor-cycle, your old cricket bat, the lot, -every single thing.

Ask yourself, "How would you like to have a group of hybrid Aboriginals move in with you? -and especially if they refuse to wash any pots or even to flush the toilet." Think about it.

**If you choose to make a fuss, the Police, and the Courts will be on their side  
 because the job of the Police is to enforce the law, be it a good law or a bad law.**

If they own one third of your house you would never be able to sell it without their consent, and when you do, they would get one third of the sale price, and it is probable that you would not be able to take your money out of Australia without Aboriginal authorization, which you would be unlikely to get.

It gets even worse.

According to Mansell, 'One Third of each of the Banks will also become Aboriginal property',  
-because the banks, -the same as with your house, landed on Aboriginal soil one brick at a time,  
-and it will include One Third of the money contained in the Banks.

**It is your hard-earned savings we are talking about.**

**Albanese didn't tell you about that, did he ?**

An intelligent person would now immediately convert his/her Australian assets into cash and that means selling your house, -if you can, -because you won't be the only one trying to do so, and to then transfer your money into an account in another country.

It might also be wise to convert Australian Dollars into a safer currency, and if you do decide to do it, it needs to be done before Albanese's Referendum happens, because it will be absolutely certain that one part of this newly invented Aboriginal Law will prohibit the transfer of money and assets out of Australia without their written permission.

**Enshrining 'the Secret Details' of Pearson's 'Voice to Parliament' in our Constitution  
 will completely cripple Australia.**

It was Albanese who decided to hold the Referendum.

It is Albanese who is pressing us to vote 'Yes'.

On page 1, this writer suggested that there was a motive behind Albanese's actions.

There is no proof for what now follows, nor can there ever be,  
because Albanese and Pearson and their gangs will deny everything, but-

- 2, **“How then do you intend to extract reparation from the ‘Invaders’ in order to compensate  
the Aboriginal people for ‘the hurt, the distress and the damage’  
caused to them by the Invaders?”**

**It is critically important that these questions be asked, -and answered,  
and that the answers be recorded.**

**If their answers are not indelibly on the record, there is no point in asking the questions.**

If the questions on the previous page, -page 46, are asked of Pearson and Albanese,  
 -and of Mayo, Burney, Davis, Langton and Dodson,  
 and if they each assure us that they have no intention of using the 2023 Referendum  
 to make any undeclared changes to our Constitution  
 other than appointing an unknown number of un-named persons  
 to advise the Government of the day on Aboriginal matters,  
**and if they then use the Referendum to sneak-through Secret-Changes to our Constitution,**  
**it is hoped that the Australian High Court**  
**might then declare the Referendum to have been unlawful and therefore invalid,**  
**and that the Australian Constitution would then revert to its pre-Referendum status.**

**That is if the Australian High Court has such powers.**  
**If it hasn't, then we would be in big trouble.**

In the event of the Referendum being revoked by the Australian High Court  
 then those criminals, Albanese and Pearson and their gangs,  
 together with the executives of those companies, banks, and sporting organisations,  
 and those politicians who so stupidly gave their unqualified endorsement  
 to Pearson's and Albanese's scheme, **should be put on trial for Treason.**

## Summarising

 nor would they ever knowingly allow a referendum for the purpose  
 of enshrining Aboriginal Law over the existing Australian Law.

**The only way that Pearson and his gang could achieve these changes, is by stealth,  
 -by underhandedness, by treachery, by fraud, and by deceit.**

**This so-called "Referendum to enshrine 'a Voice' to Parliament" is a deception.**

**It is merely a cover, that Pearson and his gang are using  
 in order to conceal 'the Secret Changes' that they are planning to make to our Constitution,**  
 -and this writer is convinced that Anthony Albanese, the Prime Minister of Australia  
 is a **knowing party** to the Secret Changes and to the deceit,

because Albanese thinks that 'he' is going to become the President of the new Republic,  
 and he is prepared to sacrifice the well-being of his fellow Australians in order to achieve it.  
**'That' explains Albanese's secrecy, and his refusal to straightforwardly answer questions.**

Instead of being open and honest, -and telling us exactly what is involved,  
 Albanese and Burney are telling us–

In Parliament, Linda Burney reads only pre-prepared statements  
 and she refuses to answer straightforward questions.

Likewise, Albanese refuses to answer straightforward questions.

**This coming Referendum is not a joke. It is a very serious matter,  
 and if you vote to approve something about which you know nothing at all  
 then you deserve to suffer whatever lies in store.**

Noel Pearson, the man behind the move to hold a referendum, tells us–

**“It’s all about taking ownership of Australia.”**

and

**“On ‘Invasion-Day’ we did not concede Sovereignty.”**

**If Australia votes ‘Yes’,  
 then the day after the Referendum is declared you will wake to find yourself living in
